2. Scope of Alterations

3. Fittings and Appointments

1. Number of Fittings: The Client understands that at least three (3) fittings are typically required for proper alterations. Additional fittings may be needed based on the complexity of the work.
2. Missed Appointments: A missed fitting appointment without 24-hour notice may incur a fee of \$50 (fifty).

4. Payment Terms

1. Cost Estimate: The total estimated cost for alterations is \$_____.
2. Deposit: A non-refundable deposit of \$400 (four hundred) is required before work begins.
3. Balance: The remaining balance must be paid in full upon completion of the alterations, prior to the release of the dress to the Client.

The Shop will make every reasonable effort to meet the agreed-upon completion date, provided that the Client attends all scheduled fittings and makes timely decisions about changes.

6. Dress Condition and Liability

1. Pre-Alteration Condition: The Shop is not responsible for any pre-existing damage, stains, or defects in the dress.
2. Post-Alteration Condition: The Shop will make every effort to ensure high-quality alterations. Any concerns about workmanship must be addressed at the final fitting.
3. Damage or Loss: The Shop's liability for any damage or loss is limited to the cost of alterations paid by the Client.

7. Cancellation Policy

1. Client Cancellation: If the Client cancels alterations after work has begun, the Client will be charged for all completed work and materials up to the cancellation date.
2. Shop Cancellation: If the Shop cancels the contract for any reason, the Client will receive a full refund of all payments made.

8. No Warranty

The Shop does not guarantee that the altered dress will fit if the Client's measurements change due to weight fluctuations, pregnancy, or other physical changes. Additional charges may apply for adjustments in such cases.

9. Force Majeure

The Shop is not liable for delays or inability to perform due to events beyond its control, such as natural disasters, illness, or other unforeseen circumstances.
